Objective of the Assignment: The broad objective of the consultancy assignment isto prepare a revival plan for ASAMB as a viable and self sustained organization, to enable it to function as a lead sector management organization for efficient service delivery to the stakeholder in the field of agricultural marketing in the state under the provisions of the AAPLM Act, 2020.

The overall scope of assignment would include (i) a detailed study and analysis of the present status and functioning of ASAMB and Regulated Market Committees thereunder; (ii) study of the prospectiverole and responsibilities of ASAMB as per the provisions of AAPLM Act, 2020; (iii) based on the above, prepare a comprehensive and implementable revival plan for ASAMB to transform it into a self-sustaining organization in the long run.
