Minimum Qualifications: Bachelors degree in Agriculture/Horticulture from any recognized university/ Institution.**Experience:** DHC must possess at **least three years** of professional experience in Horticulture related activities/ Agriculture extension or related activities in any public/private sector organization. **Computer Skills:** The DHC must have experience of using Internet based applications, using and working with advanced word processing/spreadsheet including MS Word, MS Excel and MS Power Point and other related applications. **Language proficiency:** Good knowledge of written & spoken English and Hindi. **Age:** The maximum age of the candidate should be 45 years as on 1st June 2019. **Indicative range of remuneration:** Rs. **4.80 Lakh** to Rs. **6.00 Lakh** per year. However the Remuneration will be around **30% hike on the last drawn CTC** of the applicants, subject to the **above indicative range**.
