## **IMPORTANT INSTRUCTIONS**

### **1. Mode of Application**

- a) Candidates willing to appear in the walk-in-interview shall –
  - i) Candidates willing to appear in the walk-in-interview must come with the duly filled (in English language) and signed prescribed Application/CV Form (available in the ARIAS Society website: <https://www.arias.in/career.html>). Any tampering with, alteration or deviation from the prescribed format may lead to rejection of the candidature.
  - ii) Candidates failing to produce the original certificates/testimonials/ documents at the time of the interview for verification against the self-attested copies submitted shall be rejected.
  - iii) If, at any stage of the recruitment process or thereafter, any information furnished in the application form or supporting documents is found to be false, misleading, incomplete, suppressed, or misrepresented, the candidature/engagement of the candidate shall be liable for cancellation without further notice. ARIAS Society reserves the right to verify educational qualifications and experience from issuing authorities.
  - iv) Applications submitted through email or by post shall not be entertained and shall be summarily rejected.

### **2. Selection Procedure**

- a) Depending upon the number of candidates and requirements of the position, the Selection Committee may conduct a MCQ based written test, practical test and /or, presentation on a given topic followed by personal interview.
- b) Candidates may be required to appear in a written test or make presentation, which will be Personal Interview by an Interview Panel.
- c) Selected candidates shall be engaged against the vacant positions/as per project requirements, purely in order of merit, based on the total marks obtained both in written test/presentation and the personal interview.

### **3. Contract Terms**

- a) The selected candidates shall be engaged purely on contractual basis and the initial period of engagement shall be for a period of eleven (11) months. The contract may be renewed

based on the project requirements and the candidate's satisfactory performance. The engagement shall not confer any right to regular appointment or absorption under the ARIAS Society or under the Government of Assam/India.

- b) If considered necessary by the State Project Director, ARIAS Society, engagement of selected candidate shall be subject to the candidate being declared medically fit by competent authority of the Health & Family Welfare Department of the Government of Assam. Moreover, engagement may also be subject to police verification and reference checks.
- c) The consolidated fixed remuneration per month shall be fixed within the advertised remuneration range, taking into consideration the candidate's qualifications, relevant experience, competencies, and last drawn remuneration.
  - i) The final consolidated fixed remuneration per month for the selected candidate shall be determined by the ARIAS Society and mutually agreed upon with the selected candidate.
  - ii) In cases where the candidate's last drawn monthly remuneration is lesser than the advertised range of the consolidated fixed monthly remuneration, the offered remuneration shall be minimum of the range of remuneration mentioned in the table above, unless otherwise approved by the competent authority based on exceptional merit and project requirements.
  - iii) In cases where the candidate's last drawn monthly remuneration is higher than the advertised range of the consolidated fixed monthly remuneration, the offered remuneration shall be maximum of the range of remuneration mentioned in the table above, unless otherwise approved by the competent authority based on exceptional merit and project requirements.
  - iv) In case the successful/selected candidate happens to be a retired Government Servant, relevant rules of the Government shall be applicable and the monthly fixed remuneration of the incumbent shall be fixed based on the principle of "Last Pay – Minus – Pension" of the Govt. of Assam.
- d) The engagement shall not create any employer-employee relationship with the Government of Assam or Government of India.
- e) **As per the EXECUTIVE ORDER No. FEC (II).670250/5 Dated 26-02-2026 of the Finance Department, Govt. of Assam the following conditions shall be applicable:**
  - i) **Ceiling on annual enhancement:** The maximum permissible annual enhancement in pay/remuneration of contractual personnel shall be limited to a **ceiling of 8%**, provided the individual has rendered continuous service of eleven (11) months or more under the existing contract.
  - ii) **Condition regarding renewal/extension of contract:** Any renewal or extension of contract for contractual personnel shall be effected only after a clear **break of at least two (2) working days** between the expiry of the existing contract and commencement of the renewed/extended contract and availing prior concurrence of Finance dept as per DFPR, 2022.

#### 4. Other Conditions

- a) Candidates must disclose any actual, potential or perceived conflict of interest, including close family relationships with officials involved in the recruitment process or project implementation. Failure to disclose may result in disqualification or termination of engagement.
- b) Canvassing in any form shall lead to disqualification of the concerned candidate.

- c) Any attempt by a candidate to influence the recruitment process through improper means shall result in disqualification and may be reported to the appropriate authorities.
- d) Personal data collected during the recruitment process shall be used solely for the recruitment-related purposes under the project.
