The ARIAS Society hereby invites applications for the following purely temporary contractual positions in the Project Implementation Units (PIU) and the five Cluster Project Implementation Units (CPIU) under the proposed Asian Development Bank (ADB) financed Assam Sustainable Wetland and Integrated Fisheries Transformation (SWIFT) Project. The positions (a) **Hydrology Specialist** (1-PIU) (re-advertised) and (b) **Gender Specialist** (1-PIU) (re-advertised) will be for PIU housed in the Directorate of Fisheries, Guwahati and the positions of (c) **Livelihood Coordinator** (5-CPIUs) will be housed in the 5 CPIUs located at different zones of the State.

# 1. Mode of Application:

- a. Candidates shall apply in the **prescribed Application format** available on the ARIAS website (Recruitment section). The format shall be downloaded, **typed in English** and **signed**. Tempering with the Application format or removing points/editing the Format may lead to rejection of the candidate.
- b. Candidates are required to mandatorily complete the Google Form through the link provided in the website of the ARIAS Society under the Recruitment page (<a href="https://arias.in/career.html">https://arias.in/career.html</a>) and upload scanned copy of the duly filled-in & signed Application format as prescribed, along with scanned copies of the self attested supporting documents/ certificates in the manner mentioned in the website. Applicants shall upload the required documents/certificated in pdf format and should not exceed total 10MB for all the documents. No editing of the Applications shall be allowed after final submission.
- c. Application not submitted in the above mode or incomplete applications shall be summarily rejected.

# 2. Application Timeline:

- c. Applications received after the deadline shall be not be received and summarily rejected.

#### 3. Selection Procedure:

- a. Only shortlisted candidates will be informed and called for a Written Test and/or Personal Interview.
- b. Depending on the number of shortlisted candidates, ARIAS Society may conduct only a Personal Interview or both Written Test and Interview.
- c. Tests/interviews will be held at the ARIAS Society, Khanapara, Guwahati (Assam).
- d. **No TA/DA** shall be paid for appearing in the test/interview.

# 4. Verification of Documents:

- a. Candidates must present all the original certificates/documents (commensurate with the ones submitted online) and one set of self-attested copies during the interview. Originals will be returned after verification.
- b. Any misrepresentation or false information will result in cancellation of candidature.

# 5. Contract Terms:

- a. Engagement will be **purely contractual** and initially for **11 months**, which will be renewable based on performance of the candidate and also requirement of the project.
- b. The position does not confer any right of regularization.
